**ADDENDUM NUMBER 01 TO AGREEMENT BETWEEN THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS AND FUNDACIÓN PAZ Y RECONCILIACIÓN CONCERNING COMMUNITY SECURITY OBSERVATORIES: A COMMITMENT BY THE TERRITORIES, COL-19/0009 - COMMUNITY SPACES FOR PEACE, COEXISTENCE AND RECONCILIATION**

**1. BACKGROUND**

1. The Norwegian Ministry of Foreign Affairs (MFA) and the Grant Recipient (jointly referred to as the Parties) have entered into an agreement dated 10.06.2019 (the Agreement) concerning COL-19/0009 - Community Security Observatories: A Commitment by the Territories (the Project).
2. The Grant Recipient has submitted a request to MFA dated 17.06.2022 regarding additional financial support to the Project, extension of the Support Period, and adjustment of the objectives with which MFA has decided to comply.
3. The Parties have agreed to amend the Agreement through this addendum number 01 (the Addendum), which shall be an integrated part of the Agreement.

**2. EXTENSION OF THE SUPPORT PERIOD**

1. The Support Period set forth in the Agreement shall hereby be extended to 31.01.2025.

**3. ADDITIONAL GRANT**

1. MFA shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, and this Addendum, provide an additional grant not exceeding NOK 6,843,448 (Norwegian Kroner Six million eight hundred forty-three thousand four hundred forty-eight) (the Additional Grant).
2. The Additional Grant shall be used exclusively to finance the new components of the Project as specified in the budget attached as Annex A to this Addendum and in the results framework attached as Annex B to this Addendum during the Support Period.
3. The Additional Grant shall be disbursed in advance instalments for the upcoming period, which shall not exceed six months. The disbursements shall be made upon written disbursement requests, describing the financial need for the period in question. Except for the first year, the disbursements will be subject to MFA's receipt and approval of the progress and financial reports.

The **first disbursement** shall be made upon the signing of this addendum for 50% of first year's budget and shall include approved Project expenses incurred prior to the signing of this Addendum. The starting date of this project phase is February 1<sup>st</sup> 2022.

The baseline of the results framework shall be completed during the first semester of the project period, i.e. by 31.07.2022. Before the **second installment** an updated Results Framework with the complete baseline and adjusted targets shall be delivered and approved by the Embassy

**4. ADDITIONAL AND REVISED CONDITIONS**

- a) Annual Progress and financial reports covering the period from February to January shall be submitted to MFA by February 28, each year.
- b) An audit report covering the annual financial statements of the Project shall be submitted to MFA by April 30 each year.

- c) A final report for the Support Period shall be submitted to MFA no later than 2 months after the end of the Support Period (March 31, 2025).
- d) Annual formal meetings will be held tentatively in March to review annual reports (progress and challenges) and plans for next periods.
- e) The partner will submit the Terms of Reference for the external evaluation to the Embassy for review and approval by September 30, 2022. The results of the evaluation report shall be delivered to the Embassy by 31.03.2023.

## 5. REMAINING CONDITIONS OF THE AGREEMENT

- 1. All other provisions of the Agreement shall remain unchanged and in force.

## 6. ENTRY INTO FORCE AND DURATION


- 1. The Addendum shall enter into force on the date of the last signature, and remain in force until all obligations arising from it have been fulfilled.
