**ADDENDUM NUMBER 03 TO AGREEMENT BETWEEN THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS AND FUNDACIÓN PAZ Y RECONCILIACIÓN CONCERNING COL-19/0009 - COMMUNITY SPACES FOR PEACE, COEXISTENCE AND RECONCILIATION**

**1 BACKGROUND**

- 1.1 The Norwegian Ministry of Foreign Affairs (MFA) and Fundación Paz y Reconciliación (the Grant Recipient) (jointly referred to as the Parties) have entered into an agreement dated 10.06.2019 (the Agreement) as amended by addendum number 02 dated 30.11.2023 concerning COL-19/0009 - Community Security Observatories: A Commitment by the Territories (the Project).
- 1.2 The Grant Recipient has submitted a request to MFA dated 06.12.2024 regarding additional financial support to the Project, and the extension of the Support Period with which MFA has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number 03 (the Addendum), which shall be an integrated part of the Agreement.

**2 SUPPORT PERIOD**

- 2.1 The funds and activities under the present Addendum are to be executed within a period of six months, starting on 01.02.2025. The Support Period set forth in the Agreement shall hereby be extended to 29.07.2025.

**3 ADDITIONAL GRANT**

- 3.1 MFA shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, including previous addenda, and this Addendum, provide an additional grant not exceeding NOK 1,000,000 (Norwegian Kroner one million) (the Additional Grant).
- 3.2 The Additional Grant shall be used exclusively to finance the Project as specified in the budget attached as Annex A to this Addendum, and in the Application during the Support Period.
- 3.3 The Additional Grant shall be disbursed upon signing of this Addendum

**4 ADDITIONAL AND REVISED CONDITIONS**

- 4.1 A **final narrative report** and **final financial report** shall cover the entire Support Period and shall be submitted to the Embassy no later than 2 months after the end of the Support Period, i.e., by 01.10.2025. The financial report shall include the content specified in article 3 of the General Conditions.
- 4.2 An **audit report** covering the financial statements of the Project shall be submitted 01.10.2025. The audit report shall comply with the requirements set out in article 7 of the Specific Conditions and article 5 of the General Conditions in the original agreement. If the auditor submits a management letter (matters for governance attention) this shall be attached to the audit report.
- 4.3 An **annual formal meeting** shall be held tentatively by 09.04.2025 to review the annual reports (progress and challenges) submitted on 28.02.2025 and plans for the next period.

## **6 ENTRY INTO FORCE AND DURATION**



6.1 The Addendum shall enter into force on the date of the last signature, and remain in force until all obligations arising from it have been fulfilled.
