ADDENDUM NUMBER 04 TO AGREEMENT BETWEEN THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS AND FUNDACIÓN PAZ Y RECONCILIACIÓN CONCERNING COMMUNITY SPACES FOR PEACE COEXISTENCE AND RECONCILIATION, COL – 19/0009

1 BACKGROUND

- 1.1 The Norwegian Ministry of Foreign Affairs (the Donor) and Fundación Paz y Reconciliación (the Grant Recipient) (jointly referred to as the Parties) have entered into an agreement dated 10.06.2019 (the Agreement) as amended by addendum number 03 dated 11.12.2024 concerning COL-19/0009 Community Security Observatories: A Commitment by the Territories (the Project).
- 1.2 The Grant Recipient has submitted a request to the Donor dated 11.11.2025 regarding additional financial support to the Project, and the extension of the Support Period with which the Donor has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number 04 (the Addendum), which shall be an integrated part of the Agreement.

2 EXTENSION OF THE SUPPORT PERIOD

- 2.1 The Support Period set forth in the Agreement shall hereby be extended to from 01.11.2025 to 18.11.2026.

3 ADDITIONAL GRANT

- 3.1 The Donor shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, including previous addenda, and this Addendum, provide an additional grant not exceeding NOK 3,000,000 (Norwegian Kroner three million) (the Additional Grant).
- 3.2 The Additional Grant shall be used exclusively to finance the Project in accordance with the Application dated 11.11.2025. A revised Agreement budget (Annex A) which includes the Additional Grant is attached to this Addendum.
- 3.3 The Additional Grant shall be disbursed in two disbursements. The first disbursement may be made upon signature of addendum 04 based on the approved Application. The second disbursement shall be made upon MFA's receipt of written disbursement request from the Grant Recipient, describing the financial need for the period in question.

4 ADDITIONAL AND REVISED CONDITIONS

- 4.1 A **final narrative report** and **financial report** shall cover the entire Support Period and shall be submitted to the Embassy no later than 2 months after the end of the Support Period, i.e., by 18.02.2027. The financial report shall include the content specified in article 3 of General Conditions.
- 4.2 An **audit report** covering the financial statements of the Project shall be submitted by 18.02.2027. The audit report shall comply with the requirements set out in article 7 of the Specific Conditions and article 5 of the General Conditions in the original agreement. If the auditor submits a management letter (matters for governance attention) this shall be attached to the audit report.
- 4.3 An **annual formal meeting** shall be held tentatively by 17.03.2026 to review the annual reports (progress and challenges) submitted on 30.01.2026 and plans for the next period.

5.1 All other provisions of the Agreement shall remain unchanged and in force.


6 ENTRY INTO FORCE AND DURATION
